- (ii) TTR Associates, LLC, a limited liability company organized under the laws of the State of Delaware ("TTRA"), which serves as the investment adviser to certain managed accounts, with respect to shares held by certain managed accounts managed by it;
- (iii) Jeffrey L. Gendell, a United States citizen ("Mr. Gendell"), with respect to the shares of Common Stock owned directly by TCOM II and certain managed accounts managed by TTRA.

The foregoing persons are hereinafter sometimes collectively referred to as the "Reporting Persons." Any disclosures herein with respect to persons other than the Reporting Persons are made on information and belief after making inquiry to the appropriate party.
