- The total number of non-derivative securities beneficially owned by Steven J. Golsen following the reported transaction is comprised as follows: (a) 206,987 shares held directly; (b) 78,954 shares are indirectly held by Steven J. Golsen for the benefit of the Grandchildren's Trusts, of which Steven J. Golsen is a co-trustee; and (c) 1,424,299 shares beneficially owned by SBL Corporation ("SBL"), which is wholly owned by Sylvia Golsen (40% owner), Barry Golsen (20% owner), Steven Golsen (20% owner), and Linda Rappaport (20% owner), over which Steven J. Golsen has indirect beneficial ownership. The number of shares beneficially owned by SBL includes shares owned beneficially by Golsen Petroleum Corporation, the wholly owned subsidiary of SBL.
