- 1. These shares are held of record by six trusts (the "Granchildren's Trusts") established for the benefit of the grandchildren of Jack E. Golsen and Sylvia H. Golsen. Barry H. Golsen is a co-trustee of these trusts.
- 2. The total number of non-derivative securities beneficially owned by Barry H. Golsen following the reported transaction is comprised as follows: (a) 246,616 shares held directly; (b) 222,506 shares are indirectly held by Barry H. Golsen for the benefit of the Grandchildren's Trusts, of which Barry H. Golsen is a co-trustee; and (c) 1,424,299 shares beneficially owned by SBL Corporation ("SBL"), which is wholly owned by Sylvia Golsen (40% owner), Barry Golsen (20% owner), Steven Golsen (20% owner), and Linda Rappaport (20% owner), over which Barry H. Golsen has indirect beneficial ownership. The number of shares beneficially owned by SBL includes shares owned beneficially by Golsen Petroleum Corporation, the wholly owned subsidiary of SBL. This total amount does not include 533 shares of Common Stock owned of record by Barry H. Golsen's wife. Barry H. Golsen disclaims beneficial ownership of the shares owned by his wife.
